MEMBERSHIP RULES

- 1.1 Any individual over the age of eighteen years shall be eligible for membership of the society and may be recruited into membership subject to the approval of the Executive Committee. Such a member shall pay a non-refundable registration fee as prescribed in the relevant fee category.
- 1.2 Every member shall pay an annual subscription as per fee category.
- 1.3 "Active Member" is one who is regular in attendance of regular meetings and in participation of Society's activities, enthusiastic in promoting the objects of the Society, pays his dues to the Society in time and approved and minuted as an Active member in an Executive committee meeting.
- 1.4 "Eligible Member" is one who is either a Founder member or an active member and is entitled to vote in the general or special meetings and to be elected as an Executive committee member.
- 1.5 The Executive committee will decide from time to time the amounts due from members towards entrance fees, annual membership fees, fees related to specific programmes or facilities.
- 1.6 If any amount due from a member is in arrears for more than six months and the Executive committee is not satisfied as to the reason for non-payment, such member shall cease to be an Active Member of the Society.
- 1.7 The Executive Committee shall have the responsibility of formally admitting and registering the members.

TERMINATION OF MEMBERSHIP

- 2.1 Membership of a person shall terminate due to his resignation upon giving one month's notice in writing to the Society of his intention so to resign.
- 2.2 Any Active Member who absents himself from regular meetings for a period of six months or fails to participate in the activities of the Society for a continuous period of six months without giving any acceptable cause shall cease to be an Active Member.
- 2.3 A person shall cease to be an Active Member once he/she ceases to perform as per 1.3 above.

- 2.4 Any member may be expelled from membership if the Executive Committee so recommends and if a general meeting of the society shall resolve by a two-thirds majority of the members present that such a member should be expelled on the grounds that his/her conduct has adversely affected the reputation or dignity of the society or that he has contravened the provisions of the Association's constitution.
- 2.5 The Executive Committee shall have power to suspend a member from its membership until the next general meeting of the society following such suspension but notwithstanding such suspension a member whose expulsion is proposed shall have the right to address the general meeting at which his expulsion is to be discussed.
- 2.6 If a member affected by 2.1 or 2.2 or 2.3 above, were a member of the Executive committee or a co-opted office bearer, he shall hand over all documents belonging to the Society and a progress report of his activities related to the Society to the Secretary.
- 2.7 Upon resignation or removal from membership, the member shall not be entitled to a refund of his/her subscription or any part thereof or any moneys contributed by him at any time.
